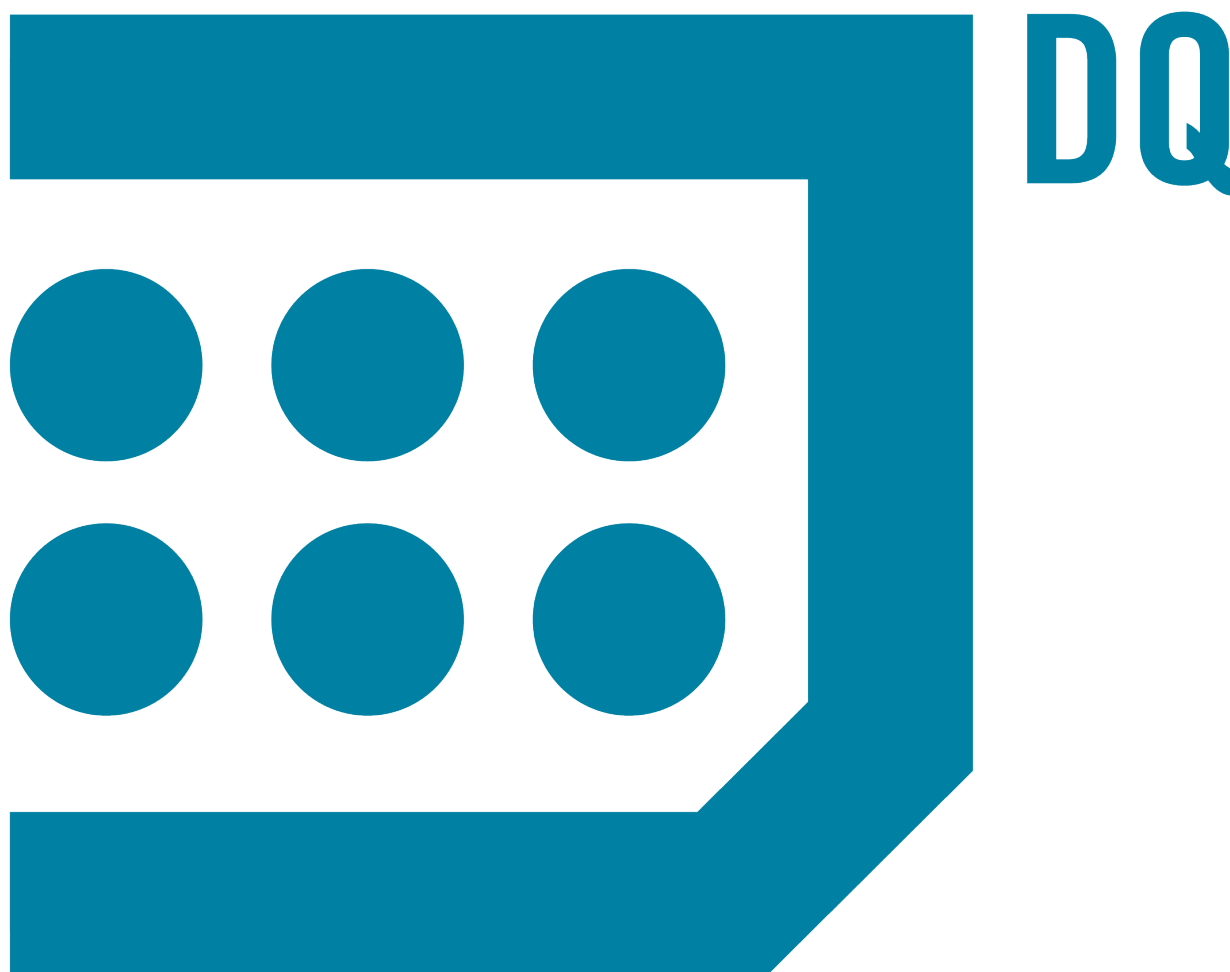

New Features and Enhancements in Version 3.0

New User Interface

- Version 3.0 of the DiscoveryQuant™ software combines the DiscoveryQuant-Analyze software and the DiscoveryQuant-Optimize software in one application.
- The single application allows combined Optimize and Analyze workflows.
- The new Compound Summary pane shows the complete tune history for Optimize experiments and ChromaTune experiments in a single view.

New ChromaTune Feature

- Users can validate MRMs from QuickTune and FineTune on column.
- Compounds can be screened based on chromatographic properties such as sensitivity, retention time, peak width, and peak tailing.
- Users can perform linearity response checks across multiple plate dilutions.

Support for TripleTOF Systems (TripleTOF 4600, 5600, and 6600)

- Analyze setup and Analyze review features are available using the Analyst® TF 1.7 software data acquisition.
- Supported TripleTOF™ TOF method types: TOF MS and Product Ion.
- Connect to an existing DiscoveryQuant software database to use the mass information for data extraction.
- Optimize features are not supported.

New Peptide Optimization and Quantitation Features

- Improved workflow for the tuning and analysis of small peptides and large protein digests.
- Dynamic product ion start mass to focus on high mass product ions.
- y and b ion mass labels on product ion spectrum in Optimize Review.
- Ability to create custom amino acid side chain modifications with new peptide editor.
- Peptide sequence and charge state added to search.
- Import tool for peptide transitions from Skyline software (MacCoss Lab Software).

Improvements to Analyze Setup

- New cassetting user interface with options to set the mass interference to zero, automatically exclude errors and highlight mass interference errors, and include internal standards in interference checks.
- Users can create methods using polarity switching on 4500, 5500, and 6500 series of systems.
- The dwell time can be set through the Analyze experiment.
- Users can create custom comments for tables.
- Using LIMS import, cassetted compounds can have different concentrations.

Improvements to Analyze Review

- Individual standards from a calibration curve can be rejected without having to change the sample type.
- Ability to sum multiple Q3 ions.
- Peak processing can be done per MRM or per analyte.

Improvements to Optimize Setup

- **Original Submitters**, **Original Plate**, and **Plate ID** are new columns that are associated with a record. The columns are kept with **Compound ID** but are not searchable. The **User Name**, **Lab Name**, **Lab Group Name**, **Project Name**, and **Project Code** are searchable.
- In version 3.0, in batches with optimize experiments with **QuickTune** and **FineTune** experiments, if there are no passing conditions for the compounds after the **QuickTune** experiment, then the **FineTune** will not run.

Improvements with MultiQuant 3.0 Software Integration

- **Compound ID** from the DiscoveryQuant 3.0 software database is now incorporated in the MRM method and the subsequent .wiff files.
- Analyte concentration information is written in the .wiff file as concentration (not weight-to-volume).
- MultiQuant™ 3.0 software allows isomers in the same results table with the same MRM to be plotted on separate calibration curves, provided they have a unique compound ID (enabled through the DiscoveryQuant 3.0 software).

Improvements to Edit Compounds Workspace

Previously, only the Load from Database option was available to search when editing compounds. Now data can be searched and modified using saved searches.

Install the DiscoveryQuant™ 3.0 Software

Use this procedure if you are installing the DiscoveryQuant software for the first time.

1. Download the DiscoveryQuant 3.0 Installer.zip from the Web site and then extract the installation files.
2. Double-click **setup.exe** and then follow the on-screen instructions.

The installer will install Microsoft .NET 4.5.2 if it is not detected on the system. It will also install the LabView runtime if required.

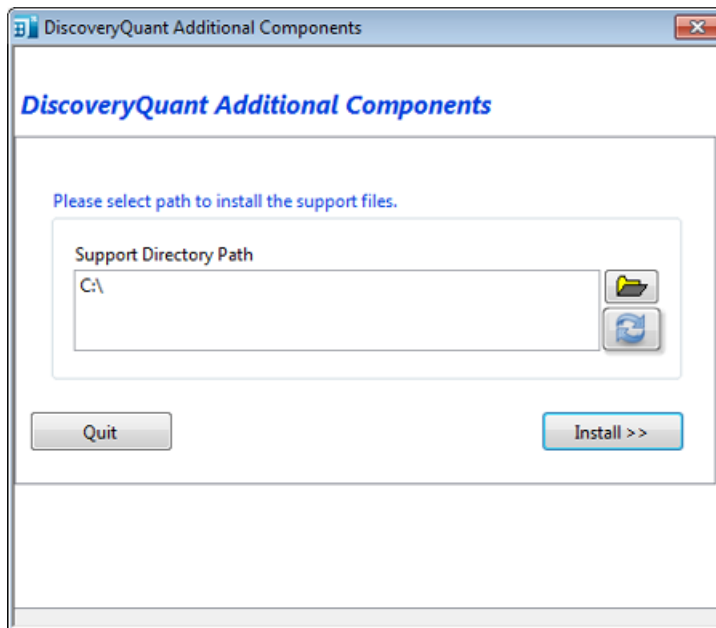
Upgrade the Software from versions 2.1.2 or 2.1.3

1. Back up the compoundDB21.mdb database.
2. Back up the DiscoveryQuant-Analyze21.mdb database.
3. Download the DiscoveryQuant 3.0 Installer.zip from the Web site and then extract the installation files.
4. Double-click **setup.exe**.

The prerequisite software is automatically installed.

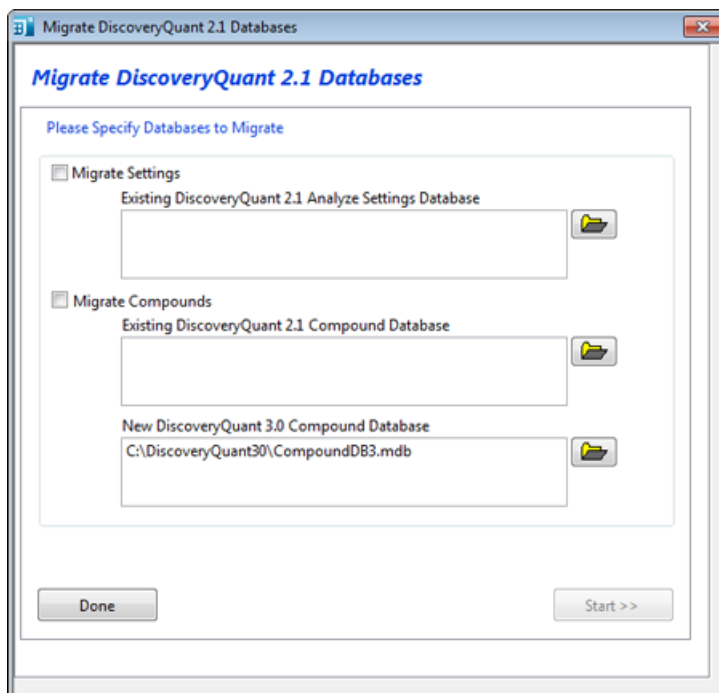
5. Specify the support directory: C:\DiscoveryQuant30 and then click **Install**.

6. In the **Migrate DiscoveryQuant 2.1 Databases** dialog, select the existing databases and then click **Start**.

- For DiscoveryQuant 2.1.3 software, the paths are C:\DiscoveryQuant\CompoundDB21.mdb and C:\DiscoveryQuant\Analyze\DiscoveryQuant-Analyze21.mdb.
 - For DiscoveryQuant 2.1.2 software, the paths are C:\ProgramFiles\DiscoveryQuant\CompoundDB21.mdb and C:\ProgramFiles\DiscoveryQuant\Analyze\DiscoveryQuant-Analyze21.mdb
7. Migrate the settings and compounds.
 8. Remove version 2.1.x.

- **Analyze Review** sessions saved in version 2.1 will not work in version 3.0 and any data must be acquired again. Contact <http://www.absciex.com/contact-us> for help in converting the data.
- In DiscoveryQuant software version 2.1.x, users were warned if the files were locked and they were asked if they wanted to unlock them. In version 3.0, the software unlocks the files (configuration and database files) without asking.
- The scripts to create a Microsoft SQL server Global database are located in C: DiscoveryQuant30\data. The scripts are only compatible with Microsoft SQL server 2014.
- When Analyze batches are submitted in a combined workflow with Optimize batches, the software will only use the first Q3 fragment found in the preceding Optimize batch to create the MRM method.
- When submitting the combined workflow batches with cassetted Analyze samples, if one compound in the cassette fails the Optimize experiment, then the Analyze batch will terminate.
- ChromaTune batches cannot be submitted using conditions that exist only in the global database.
- The Global database is designed to hold results. Optimize and ChromaTune experiment settings and ChromaTune review settings are not transferred to the Upload database using the Upload Data tool. To view ChromaTune results in the Global database, use the Compound Summary panel. The ChromaTune Review panel is designed to review data acquired to the local database.
- Although all of the compounds are in the database, the software only loads the most recent batch entry to the **Review Analyze** workspace under the following conditions:
 1. The user enters a set of compounds in the database using the **Edit Compounds** function with a batch name.
 2. The user enters a different set or subset of compounds with the same batch name.
In the **Analyze Setup** workspace, the **Load From Database** function returns the latest set of compounds associated with the batch name.
